Membership subscriptions are paid annually. The membership year runs from the date that your membership is accepted to the same date the following year. The Society will send out a reminder by email one month before your membership will expire.

You may join at any time and will receive the full complement of quarterly Journals dependent upon the time of year.

A full member may apply for household membership, at a reduced rate, for any person permanently residing at the full member's address. Only full members receive the Journal. All other society facilities and privileges are open to household members.

Special rates apply to institutions, other than those in Northumberland and Durham.
